
NOTICE INVITING QUOTATIONS FOR SUPPLY AND INSTALLATION OF 2.0 TON SPLIT AIR CONDITIONER WITH ACCESSORIES IN THE ART CLINIC AT 4TH FLOOR OF THIS HOSPITAL

Quotations are invited for Supply and Installation of 2.0 Ton Split Air Conditioner with Accessories in the ART Clinic at Fourth Floor of this Hospital as per annexure.

2. Under the terms and conditions detailed below, quotations may be submitted on or before 31.01.2026 till 4.00 p.m. by post / in person furnishing the competitive rates, for the Supply of Air Conditioners as per Annexure, in a closed envelope addressed to the "Medical Superintendent, Rajiv Gandhi Government Women and Children Hospital, Ellaipillaichavady, Puducherry – 605 005, and with "Quotation for Supply & Installation of 2.0 ton A.C." marked on it:

- i. The rates quoted by the Firm/Distributor/Dealer shall be for the Supply & Installation as mentioned in the Annexure which includes the materials and other items required for the installation. The rates quoted shall be inclusive of insurance charges, if any. No insurance charges, like transit insurance, etc., will be paid by the purchaser. The firm/distributor/dealer shall be solely responsible for the safe delivery of goods in good condition. However, GST may be charged as applicable.
- ii. The rates once quoted and approved shall be final and valid for one year from the date of finalization of the lowest bidder. No violation will be accepted in this regard.
- iii. The materials/items to be used in the work shall conform to I.S. standard.
- iv. The supply to be made and works to be carried out shall be strictly in accordance with the specifications mentioned in the Supply Order. Any item, which is not up to the specification or is damaged, will have to be reworked by the firm/distributor/dealer at their own cost.
- v. The supply shall be made, as per the time schedule mentioned in the Supply Order, at Rajiv Gandhi Government Women and Children Hospital, Ellaipillaichavady, Puducherry - 605 005, by the safest mode. If supply is not commenced within the time schedule, the order placed with L1 shall stand cancelled and be placed with L2 without any notice to L1. No further correspondence shall be entertained from L1 and this Hospital will not take any responsibility for any loss.
- vi. The details of company's account for payment through the Electronic Clearing Service (ECS) and other important nos. under the GST regime and PAN shall be mandatorily mentioned in the quotation.
- vii. The firm can, if wishes to, inspect the site on any working day on prior intimation and with prior permission before submission of quotation.
- viii. The prices offered in the quotation should include all the charges and no separate charges except GST will be paid by this Hospital.
- ix. The quotations received either by post or in person after the due date and time shall be summarily rejected.
- x. The Hospital Administration reserves the right to cancel this quotation without assigning any reason at any point in time.

3. The Payment through the ECS will be made after supply is made completely and the completion of works in good condition and after the receipt of pre-receipted, stamped bill in duplicate.
