**NOTICE INVITING QUOTATIONS FOR TABLET ITEMS**

Quotations are invited for the supply of Tablets to this Hospital as per the details mentioned below.

2. **Under the terms and conditions detailed below,** quotations may be submitted **on or before 06.04.2026 till 4.00 p.m. by post/in person** furnishing the competitive rates, for the Supply of Tab. Dicyclomine 20mg, Tablet Mefenamic Acid 500mg & Tablet Clotrimazole Vaginal (V6), in a closed envelope addressed to the "Medical Superintendent, Rajiv Gandhi Government Women and Children Hospital, Ellaipillaichavady, Puducherry – 605 005, and with "**Quotation for Supply of Tab. Dicyclomine 20mg, Tablet Mefenamic Acid 500mg & Tablet Clotrimazole Vaginal (V6)**" marked on it:

- i. **The rates quoted by the supplier shall be for the Products either branded/proprietary or compatible. Branded/ Proprietary Products may be accepted only when compatible products are not available for a certain item.** The rates quoted shall be inclusive of insurance charges, if any. No insurance charges, like transit insurance, etc., will be paid by the purchaser. The supplier shall be solely responsible for the safe delivery of goods in good condition. However, GST may be charged as applicable.
- ii. **The rates once quoted and approved shall be final and valid for one year from the date of finalization of the lowest bidder and applicable even to the supply of a small quantity of required items. No violation will be accepted in this regard.**
- iii. **The items supplied shall have a minimum expiry of 18 months.**
- iv. The items to be supplied shall be strictly in accordance with the specifications mentioned in the supply order. Any item, which is not up to the specification or is damaged, will be returned to the suppliers at their own cost.
- v. The goods shall be delivered immediately after the issue of supply orders to the Pharmacy Store, Rajiv Gandhi Government Women and Children Hospital, Ellaipillaichavady, Puducherry - 605 005, by the safest mode of conveyance at the risk of the supplier. **If supply is not commenced within one week, the order placed with L1 shall stand cancelled and be placed with L2 without any notice to L1. If untimely supply is made even after this cancellation without the consent of the Hospital Pharmacy Store, this Hospital will not take any responsibility for any loss.**
- vi. The items shall be supplied direct to the consignee place (The Medical Superintendent, Rajiv Gandhi Government Women and Children Hospital, Puducherry.) by any mode but not through bank.
- vii. The details of company's account for payment through the Electronic Clearing Service (ECS) and other important nos. under the GST regime, DL and PAN shall be mandatorily mentioned in the quotation.
- viii. The quotations received either by post or in person after the due date and time shall be summarily rejected.

3. The Payment through the ECS will be made after the receipt of goods in good condition and after the receipt of pre-receipted, stamped bill in duplicate **ALONG WITH THE COPIES OF SUPPLY ORDER(S).**
