# 1.Servicing Terms and Conditions

The Bidder must inspect all the defunct machine as enclosed in the Annexure and should prepare a report of the faults and the spares to be replaced in each machines and must enclose alongwith the quotations

- 1.1 The Bidder must also indicate the warranty period of the spares which are need to be
- 1.2 The old of defective parts must be submitted to this Hospital Stores Department.
- 1.3 The rates quoted by the Bidder shall be inclusive of GST, service and insurance charges, if any. No insurance charges, like transit insurance, will be paid by this Hospital. The Bidder shall be solely responsible for installation and the safe delivery of goods in good condition.
- 1.4 During the warranty period it is the responsibility of the Bidder to rectify/replace the faulty spares with new ones which are found to be defective.
- 1.5 Losses incurred due to mishandling / misplacement / theft or any malpractice by technicians during the period of servicing, the has to / make good of the losses suffered by the Institution due to fault In case of non – reimbursement / making good by the Bidder, the same will be recovered from the bills by Institution.
- No advance payment will be made under any circumstances.

### 2. Validity of the Quotations

- 2.1The rates once quoted and approved shall be final and valid for one year from the date of opening of quotations and shall be applicable even to the servicing of minimum quantity of defunct machines in phased manner and no deviation will be accepted in enhancement of rates by the bidder.
- 2.2 If rectification of faults is not commenced within one week, the order placed to L1 shall stand cancelled and be placed to L2 without any notice to L1.
- 2.3The quotations received either by post or in person after the due date and time will be summarily rejected.

#### 3. Financial Conditions

- 3.1 The Firm should be a Company in operation for at least one year as on 31st May 2024 in the business of Reverse Osmosis servicing.
- 3.2 Payment will be made through ECS after the submission of the completion certificate and work satisfactory report from the competent Authority.
